23 **OF THE FACT OF ACQUITTAL.**

25 The fact that the Defendant has been tried and acquitted of  
a (the) prior sex offense(s) which the People seek to admit per

1 Evidence Code §1108 does not bar its (their) admission into  
2 evidence. (Dowling v. United States (1990) 493 U.S. 342, 349.)  
3 However, no authority exists to preclude the defense from  
4 advising the jury of the fact of acquittal of the prior offense.

5 Defendant requests that he (she) be permitted to advise the  
6 jury of his (her) acquittal of the prior sexual offense(s) which  
7 the People will be admitting per Evidence Code §1108.
